### Asuncion solar small module export tariff

What tariffs are imposed on Chinese solar cells & modules? The U.S. had imposed several trade barriers against Chinese solar cell and module imports. In addition to the original 25% tariff under the Section 301, there are anti-dumping and countervailing duties (AD/CVD) that have been imposed since as well as the Section 201 tariffs targeting cells and modules from all countries. Will new tariffs be imposed on solar panels from Southeast Asia? The rumors were true: A new petition has been filed to the U.S. International Trade Commission (USITC) and the U.S. Department of Commerce (DOC), to apply new tariffs (both anti-dumping and countervailing duties) to imported solar cells and modules from Southeast Asia. As expected, the reaction from the U.S. solar industry depends on the source. How will the 301 tariff affect the US solar supply chain? Notably, the adjusted 301 tariff expands to cover Chinese exports of polysilicon and mono-Si wafers, with a 50% tariff rate set to take effect on January 1, .
