Note that the LG certificate number starting with "MI2" is for Gen2, "MI3" is for Gen3. How long does a battery warranty last? A standard battery warranty should come with at least 10 years of protection, though it can be shorter depending on how often you charge and drain your battery. Battery warranties typically won't reimburse for labor costs associated with installing new equipment or shipping fees for new equipment. Does a battery storage system need a warranty? A battery storage system is a decades-long investment that a warranty can help protect. The less power your system stores, the more your home may need to draw from the utility company, which eats into your savings. A good warranty ensures that if your battery experiences a problem, that it will be replaced and your investment will be protected. Does a battery warranty cover labor costs? Battery warranties typically won't reimburse for labor costs associated with installing new equipment or shipping fees for new equipment.
